

RMI API TERMS OF USE

Please read these Terms of Use ("Terms", "Terms of Use") carefully before using the API's (the "Service") operated by Reverse Market Insight, Inc. ("us", "we", or "our").

Your access to and use of the Service is conditioned upon your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who wish to access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you do not have permission to access the Service.

All data accessed in Service is copyrighted and you are not allowed to download or harvest the information to be used internally or be distributed to any party. We will legally prosecute any theft of our data.

Subscriptions

Data Harvesting of our data is not permitted. If found you will be banned from using our API.

Some parts of the Service are billed on a subscription basis ("Subscription(s)"). You will be billed in advance on a recurring and periodic basis ("Billing Cycle"). Billing cycles are set on a monthly basis.

At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it or Reverse Market Insight, Inc. cancels it. You may cancel your Subscription renewal by contacting us at <u>sales@rminsight.net</u>.

A valid payment method, including credit card, is required to process the payment for your Subscription. You shall provide Reverse Market Insight, Inc. with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method. By submitting such payment information, you authorize Reverse Market Insight, Inc. to automatically charge all Subscription fees incurred through your account to any such payment methods.

Should automatic billing fail to occur for any reason, Reverse Market Insight, Inc. will issue an electronic invoice indicating that you must process manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

Fee Changes

Reverse Market Insight, Inc., in its sole discretion and at any time, may modify the Subscription fees for the Subscriptions. Any Subscription fee change will become effective at the end of the then-current Billing Cycle.

Refunds

Except when required by law, paid Subscription fees are non-refundable.

Accounts

When you create an account with us, you guarantee that you are an authorized signer for the subscribing company and/or above the age of 18, and that the information you provide us is accurate,



complete, and current at all times. Inaccurate, incomplete, or obsolete information may result in the immediate termination of your account on the Service.

You are responsible for maintaining the confidentiality of your account and password, including but not limited to the restriction of access to your computer and/or account. You agree to accept responsibility for any and all activities or actions that occur under your account and/or password, whether your password is with our Service or a third-party service. Indemnification
